



REQUEST FOR PROPOSAL FROM THE WORLD INITIATIVE FOR SOY IN HUMAN HEALTH (WISHH)

I. DATE

II. PROJECT OBJECTIVE

ASA/WISHH is looking for a qualified individual, firm or other entity to implement RAPP Tranche 1 funded activities in the Cambodian aquaculture sector. The selected contractor will work closely with ASA/WISHH staff in St. Louis and Cambodia to ensure the implementation of the activities is efficient, effective and compliant with RAPP funding regulations.

III. ORGANIZATION BACKGROUND

The American Soybean Association (ASA) was founded in 1920 by soybean farmers and extension workers to promote soy for high protein applications in developmental settings. Overseas activities initiated in the mid-1950s, and to date ASA has worked in over 80 countries. The World Initiative for Soy in Human Health (WISHH) was founded in 2000 to expand the work of the American Soybean Association (ASA) in developing and emerging markets to improve health, nutrition and food security, building the groundwork for future markets of soy. WISHH provides services in food technology, business development, nutrition services, and program and proposal development. WISHH expertise extends its network into additional areas, such as aquaculture and animal feed.

ASA/WISHH connects trade and development to strengthen agricultural value chains in emerging markets, creating trade and long-term demand for U.S. soy. Trade can improve lives worldwide for both farmers and consumers. U.S. soy trade in emerging markets is pivotal to improve accessibility, affordability, and acceptability of high-quality plant and animal-sourced proteins in developing economies. Rising incomes in emerging economies generate further opportunity for trade. ASA/WISHH builds opportunity for long-term trade by improving agricultural value chains, human and animal nutrition, and farmer net incomes. ASA/WISHH initiatives broadly fit in two arenas: (1) trade-building long-term, early-stage market development, and (2) trade-building international agriculture and economic development. The St. Louis-based Program operates in sub-Saharan Africa, Asia and Central America.

ASA/WISHH offers proven feed sector capacity and decades of accumulated knowledge from ASA programs. Principal approaches include market and economic assessments, technical assistance and capacity building, food and feed trials and demonstrations, farmer field days, youth mentorship programs, food and feed value chain development, and market linkages.

ASA/WISHH achieves its mission by working in close partnership with: (1) the public sector (e.g., USDA, USAID, U.S. land grant universities, and host country governments), (2) the private sector (e.g., U.S. exporters and trade associations: Qualified State Soybean Boards and U.S. Soybean Export Council), and





(3) private voluntary organizations. The Program draws upon the resources and experience of these partners and the services of a cadre of ASA/WISHH consultants with technical expertise in agricultural, international and commercial development spheres. ASA/WISHH relies on decades of experience in food commercial development and agricultural development programming. The Program takes pride in its growing portfolio of success with U.S. government-funding, including USDA (Food for Progress, McGovern-Dole, Foreign Market Development, Market Access Program, Regional Agricultural Promotional Program, Emerging Markets Program, and Quality Samples Program) and USAID funding in both prime and sub-recipient capacities. ASA/WISHH has also attracted both private sector and other complementary funding sources from various donors to build on and leverage core funding from Qualified State Soybean Boards.

WISHH's objective is to increase the international consumption of soy protein in the human, livestock, and aquaculture sectors in new markets and thereby create new opportunities for soybeans and providing higher economic returns to U.S. soybean producers.

IV. SCOPE OF WORK

The selected firm will implement activities in the Cambodian aquaculture sector. These activities may include in-person regional training and educational events, attendance and promotion of Cambodian aquaculture at World Aquaculture Society (WAS) conferences and meetings, hosting in-country discussions focused on strengthening the aquaculture value chains with local stakeholders, organizing technical consultant visits, arranging trade team travel to regional and global aquaculture conferences, along with providing administrative support including report writing, submitting compliant receipts and distributing surveys to activity participants. Previous work in the Cambodian aquaculture industry is preferred.

Prior to the start of each activity year, the selected contractor will work with WISHH to prepare a calendar of events for the upcoming program year, with a focus on targeted audiences, timelines, available funding and using results from past activities. A new SOW will then be developed to implement activities for the upcoming fiscal year.

This activity will start in February 2025 and run through June 2029, or when RAPP Tranche 1 activity funding has been spent. The selected firm or individual will have an annual contract.

V. TIMING

Final deliverables and invoice for the activities implemented for the first year are due on October 10, 2025.

VI. SELECTION CRITERIA AND CRITERIA WEIGHTS

Proposals submitted will be evaluated according to the following criteria:

Comprehensiveness	30%
Consultant skills/experience	35%
Cost	20%
Timing	15%
TOTAL	100%

Special consideration will be given to Women or Minority Owned Small Business (WMOSB) entities with SBA certifications (proof of certification must be provided at time of submission).

VII. INSTRUCTIONS TO BIDDERS

Proposals must contain at a minimum the specific criteria requested in the Request for Proposal:

- 1. A proposal that includes the following sections:
 - Proposal executive summary
 - Key staff professional experiences and background, along with their work location
 - Experience implementing USDA funding or similar grant funding (USAID, UN, etc)
 - Project implementation plan how will you implement the proposed activities
 - Event management (seminars or conferences) capabilities
 - Description of project management services with previous clients and organizations
 - Experience working and connections in the Cambodian aquaculture sector
 - Writing samples of activity donor reports
 - Proposed budget that includes daily or hourly project management fees and any additional costs related to the scope of work.
- 2. Checklist of additional items that must be submitted:
 - Attachment A Technical Proposal Authorization Cover Page Completed and Signed
 - Full detailed proposal with executive summary
 - Proposal detailed budget
 - WMOSB Proof of Certification (if applicable)

Proposals should be submitted no later than at 4:00 PM CST on Friday, January 31, 2025. To be considered for the award, proposals must be submitted by e-mail to Alan F. Either Mr. Poock or Mr. Jeffries will confirm receipt of each proposal; if receipt has not been confirmed, your proposal has not been received. If your proposal is not authorized by signature on Attachment A Proposal Authorization Cover Page, it may not be considered and may be rejected.





Submission of Questions: All questions regarding the preparation of proposals must be submitted in writing (by e-mail) to Alan F. No questions will be answered over the phone or in person; all questions must be in writing and sent via email.
